

Confirmation of compliance REACH-Regulation (EG) 1907/2006 and SCIP

The REACH Regulation (EC) No. 1907/2006 is the EU regulation on the registration, evaluation, and authorization of chemicals.

It regulates the handling of chemical substances in preparations and products.

The objective of the regulation is to ensure the complete traceability of chemical substances from manufacture to end use.

Our products are “articles” as defined in the REACH Regulation.

We hereby confirm following:

1. role under REACH

We are a “downstream user” and “importer” for certain product groups within the meaning of the REACH Regulation. Our products are considered “articles” (not “substances”) and are therefore not subject to registration.

2. Information on SVHC substances according to the candidate list

With the exception of the substances listed under 3, we currently have no information from our suppliers that the products we purchase contain substances from the SVHC candidate list for substances of very high concern in a concentration of >0.1%.

3. Products containing a substance included in the candidate list

A-VF 75-00	Bisphenol AF (CAS-Nr. 1478-61-1), due to the use of cross-linking agents in the process

4. Agreements with non-EU suppliers

Written agreements are in place with all non-EU suppliers to ensure regular testing of newly added substances on the SVHC candidate list.

5. Obligations of our EU suppliers

Our EU suppliers are obliged to inform us immediately and without being asked as soon as an SVHC substance is contained in a delivered product in a concentration >0.1%.

6. REACH Annex XIV (Authorisation) and Annex XVII (Restrictions)

Our products are ‘articles’ within the meaning of the REACH Regulation and are therefore not subject to the authorisation requirements set out in Annex XIV. We do not intentionally use substances that are subject to authorisation under Annex XIV in our products.

All applicable restrictions under Annex XVII of the REACH Regulation are complied with. Substances that are prohibited or restricted under Annex XVII are not used, or the relevant limit values and conditions of use are fully complied with.

We continuously monitor updates to Annexes XIV and XVII and immediately review any potential impact on our products and supply chain.

7. Information obligation pursuant to Article 33 REACH

We fulfill our obligation under Article 33 of the REACH Regulation and inform our customers immediately if any SVHC substance according to the candidate list is contained in one of our products in a concentration of >0.1%.

8. SCIP- notification

Since January 2021, products containing hazardous substances in accordance with REACH Regulation (EC) 1907/2006 must be registered in the ECHA's SCIP database.

We confirm full compliance with the reporting obligation for all articles that exceed the mass percentage threshold of 0.1% for currently listed SVHC substances. The reports are made in the ECHA's SCIP database, which is accessible to all.
